## SC State Convention

Janice Bright (S\&R Div. Secretary/Treasurer) discussed the details of purchasing the Fitbit Charge 5 Fitness Tracker. She purchased the item on 7/11/2023 from Amazon during Amazon Prime Days sales. The tracker was bought at a $\$ 60.00$ savings off the
$\$ 159.99$ original list price. $\$ 111.20$ was pulled from S\&R's PayPal account to make this purchase.

Members are allowed to purchase healthier snacks to put into our inventory to use to create snack packs to sell at the SC State Convention. Lori Anne Coley stated that she has already spent $\$ 54.46$ at Sam's Club for snack inventory and is waiting for her reimbursement.

Shannon Cook brought up the suggestion that members of S\&R station themselves at the door/entrance of the SC State convention registration hall as a great location to sell our fundraiser snack pack. All members who commented were in agreement.

## SC State Convention activities

■ Lori Anne Coley still has it on her "to do list" to get the pool schedule for the convention host hotel, so it can be determined if S\&R Div. will do a water aerobics session.

- Melinda Jones (S\&R member and SC State Convention committee member) confirmed that there is space on the convention schedule for S\&R Div. to have a session.

## Creating a S\&R Div. statewide resource

The S\&R president opened the floor for brainstorming ideas and getting feedback about creating a statewide resource for blind/low vision friendly recreation resources. Out of this discussion ideas of providing resources for activities life Go Ball, Marshall Arts, and biking were mentioned. All that gave feedback were in favor of this project and this will be an on-going project that we will talk over and formulate a plan later.

## Year-end Fundraiser

The S\&R President brought forward a suggestion for a year-end fundraiser. The idea is borrowed from the National S\&R Div., and it is a limited raffle/membership drive. The details of this fundraiser are as follows:

- There is a set raffle ticket price of $\$ 20.00$.
- $\$ 5.00$ of the $\$ 20.00$ ticket price goes towards the purchaser's S\&R Div. membership fee.
- The prize is suggested to be $\$ 1,000$.
- To increase the purchaser's odds of winning there is a limited number of tickets that will be sold. The Nat'l S\&R Div. sold 200 tix @\$20/ea. = \$4k raised - $\$ 1 \mathrm{k}$ prize $=\$ 3 \mathrm{k}$ raised before disbursing the membership dues to the treasure.
