Yet, uber and Lift want to deny blind citizens the right to travel with their dog guides. We must not allow this discriminatory behavior to continue. Steve Cook will represent South Carolina at the upcoming rally in California on October 15, 2024 as the Federation descends upon Uber and Lift headquarters. These transportation providers must do more than pay lip services, they must affect transformative change in their practices. Let's support our friends as they attend this important event.
